3. <b>First day to file Nomination Papers</b> Requires no less than 20 nor more than 30 signatures. (E.C. §10220, §10224, §10407- 113 <sup>th</sup> day prior to Election)	<b>July 13, 2020</b>
4. Last day to <b>submit Resolution</b> to County Board of Supervisors and County Clerk calling election and requesting consolidation (E.C. §10403)	<b>August 07, 2020</b>
5. <b>Last day to file Nomination Papers and Candidate Statements.</b> Must be filed concurrently. (E.C. §10220, §10224, §10407, §13307 – 88 <sup>th</sup> day prior to Election)	<b>August 07, 2020</b>
6. <b>Last day for candidates to withdraw</b> his/her <b>Nomination</b> papers, excluding extended filing period. (E.C. §10224)	<b>August 07, 2020</b>
7. <b>Last day to withdraw Candidate's Statement.</b> May not be altered or changed once filed. (E.C. §13307, §13311)	<b>August 10, 2020</b>
8. <b>First day of extension period</b> for Nomination Papers to be filed. (Applicable <u>only</u> for <b>Non-incumbent</b> , when the incumbent does not file by the deadline (E.C. §10225, §10407)	<b>August 12, 2020</b>
9. <b>Last day to file Nomination Papers and Candidate Statements</b> under the <b>extension period</b> provision. Must be filed concurrently (E.C. §10224, §10225 – 83 <sup>rd</sup> day prior to Election)	<b>August 12, 2020</b>
10. <b>Last day for candidates to withdraw</b> his/her <b>Nomination</b> papers filed under the <b>extension</b> period provision (E.C. §10225)	<b>August 12, 2020</b>
11. Last day to <b>withdraw Candidates' Statement</b> filed under the extension period provision (E.C. §13307)	<b>August 13, 2020</b>
12. <b>Randomized Alphabet Drawing by Secretary of State</b> (E.C. §13112, §13113 – 82 <sup>nd</sup> day prior to Election)	<b>August 13, 2020</b>
13. Last day for City Clerk to <b>certify</b> and file with Kern County the List of <b>Candidates</b> (G.C. §6066, E.C. §10403 – 81 <sup>st</sup> day prior to Election)	<b>August 14, 2020</b>
