RECITALS

WHEREAS, CITY and ATTORNEY entered into Agreement for Legal Services No. CA21-002 on January 7, 2021, for legal services not to exceed \$40,000 in the matter of:

Edgar Quincy Sloan v. City of Bakersfield; Bakersfield Fire Department; Chief Anthony Galagaza; Chief Michael Kelly; Deputy Chief John Frando; Deputy Chief Trever Martinusen; Deputy Chief William Ballard; And Does 1 Through 100, Inclusive Kern County Superior Court Case No. BCV-20-102749

WHEREAS, additional monies are needed to continue with outside legal services in connection with this matter;

WHEREAS, CITY and ATTORNEY desire to amend Agreement No. CA21-002 to increase the amount of compensation to ATTORNEY by the sum of Sixty Thousand Dollars (\$60,000) for a total not to exceed of One Hundred Thousand Dollars (\$100,000) for this action.

NOW, THEREFORE, incorporating the foregoing recitals herein, the parties agree as follows:

1. Paragraph 2 of Agreement for Legal Services No. CA21-002 dated January 7, 2021, is hereby amended in its entirety to read as follows:

- COMPENSATION TO ATTORNEY. Compensation 2. for all work, services or products called for under this Agreement shall be paid as follows: CITY shall compensate ATTORNEY for all services performed by ATTORNEY on an hourly basis in an amount of One Hundred Ninety-Five Dollars (\$195) per hour. In no event shall this Agreement exceed the total amount of One Hundred Thousand Dollars (\$100,000). ATTORNEY shall not engage in any services above or beyond this amount and CITY shall not be obligated to pay ATTORNEY for excess work, services or products beyond this amount. CITY shall pay ATTORNEY thirty (30) days after receipt and approval of billing and shall submit separate billings for each matter. CITY shall pay no finance charge to ATTORNEY. The compensation set forth in this section shall be the total compensation under this Agreement including, but not limited to all approved out-of-pocket costs and taxes. Prior to payment all bills shall be reviewed and approved by the City Attorney or his designee.
- 2. <u>EFFECT OF THIS AMENDMENT</u>. Except as amended in this Agreement, all of the provisions of Agreement for Legal Services No. CA21-002, dated January 7, 2021, shall remain in full force and effect.
