Deputy City Attorney Villanueva presented a powerpoint on the Ralph M. Brown Act and reviewed the Youth Commission Bylaws.

b. Election of the Chair and Co-Chair of the Bakersfield Youth Commission for FY 2023-2024

Commissioner Beardsley, Commissioner Brar, and Commissioner Batth were nominated to serve as Chair for the 2023-2024 Youth Commission.

Vote by ballot. Commissioner Brar was elected as Chair by three out of seven eligible votes.

Commissioner Thallapalle, Commissioner Webster, Commissioner Tarango, and Commissioner Simpson were nominated for Co-Chair for the 2023-2024 Youth Commission.

Vote by ballot. An initial vote ended in a tie between Commissioner Webster, Commissioner Tarango, and Commissioner Simpson. A second vote was taken with Commissioner Webster, Commissioner Tarango, and Commissioner Simpson on the ballot. Commissioner Tarango was elected as Co-Chair by a majority vote of four of the seven eligible votes.
